Dear,

I write in connection with your request for information dated 21st September 2022 concerning arrests made between the 9th – 19th September 2022.

I am required by the Freedom of Information Act 2000 to handle all requests in a manner that is blind as to the identity and motives of the requestor. Any information released as a response to a request is regarded as being published and therefore in the public domain without caveat.

Your request for information has now been considered and I am not obliged to supply the information you have requested.

You wrote:

1. How many people has your force arrested under the Police, Crime, Courts and Sentencing Act 2022 between 9 September 2022 and 19 September 2022? Please include whether or not people were charged, broken down by age, race and gender.
2. How many people has your force arrested under the Public Order Act 1986 between 9 September 2022 and 19 September 2022? Please include whether or not people were charged, broken down by age, race and gender.
3. How many people has your force arrested under the Public Order Act 1936 between 9 September 2022 and 19 September 2022? Please include whether or not people were charged, broken down by age, race and gender.
4. How many Breach of the Peace arrests did your force make between 9 September 2022 and 19 September 2022? Please include whether or not people were charged, broken down by age, race and gender.
5. Has your force received any complaints between 9 September 2022 and 19 September 2022? If so, please share how many and the details for each complaint e.g. excessive use of force.

6. If it does not push this request over the cost limit, please share how many anti-monarchy protestors your force arrested between 9 September 2023 and 19 September 2022.

Our response:

The information that you are requesting (namely question 6) is not stored in a way which permits easy retrieval. This is because this would involve us having to physically peruse the crime reports relating to all arrests made within the time frame requested to see any of those arrested were anti-monarchy protestors.

Therefore, under the circumstances I am absolutely confident that to locate, retrieve and extract the information you seek would by far exceed the time obligations upon this authority to comply, and in so doing would exceed the fees limits. This is set at £450 calculated at a flat rate of £25 per hour for those work activities comprising of confirming the information is held, locating it, retrieving it and extracting it.

Please note, that if one part of the request engages a Section 12 response, the whole request will engage a Section 12 response. The reason being is due to the fact that locating, retrieving and extracting any further information would only add to the already exceeded time obligations.

Although excess cost removes the forces' obligations under the Freedom of Information Act, as a gesture of goodwill I have supplied information, relative to your request, retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request. What I am able to provide you are the answers documented below –

5. Has your force received any complaints between 9 September 2022 and 19 September 2022? If so, please share how many and the details for each complaint e.g. excessive use of force.

The force has received 35 complaints in total in the requested time frame.

Breakdown of complaints:

Use of Force x 2

Delivery of Duties and Service x 1

Not yet assessed x 32

Whilst the above complaints are recorded, they have not gone through the assessment stage and as such do not yet have the specific details regarding the complaint type on our database.

Ordinarily under our Section 16 duty to provide advice and assistance, we would advise you how to refine your request to a more manageable level and in order to do so, I would suggest omitting question 6 from your request and providing the specific offences you would like us to search for arrests under with regards to questions 1-3 because we do not hold arrest information in the way requested (under specific Acts) etc.

Section 17 of the Freedom of Information Act 2000 requires the Wiltshire Police, when refusing to provide such information (because the information is exempt) to provide you the applicant with a notice which: (a) states that fact, (b) specifies the exemption in question and (c) states (if that would not otherwise be apparent) why the exemption applies.

The exemption applicable to the information requested is:

Section 12: Exemption where cost of compliance exceeds appropriate limit

(1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

In accordance with Section 17 of the Act, this letter represents a Refusal Notice for this particular request.

I am satisfied that all the relevant information has been passed to me and been considered in the light of your request within the time constraints applicable under the legislation.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Wiltshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing to the:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Force Disclosure Unit within 20 working days of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing to include confirmation of the reasons for the review. The review will be conducted by another Decision Maker, who is independent from the original Decision Maker. The Force Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to 40 working days.

The Independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Decision Maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review, they should contact the Information Commissioner to make an appeal.
