Dear,

I write in connection with your request for information dated 5th January 2023 concerning Freedom of Information request refusal rates within the force.

I am required by the Freedom of Information Act 2000 to handle all requests in a manner that is blind as to the identity and motives of the requestor. Any information released as a response to a request is regarded as being published and therefore in the public domain without caveat.

Your request for information has now been considered and after having consulted the Force Disclosure Unit – I am now able to respond as follows.

You wrote:

I'm writing to you under the Freedom of Information Act (2000) to ask that you please disclose to me the statistics on FOI refusal / acceptance rates from your force for the last three years (2020, 2021, and 2022) as percentages, and the reasons for the exemptions given (law enforcement, cost limit, national security etc).

raw data is fine, if that's the manner it's recorded in, but really just a list of the FOIs (without identifiable information attached) and whether they were accepted, refused, and why please.

Our response:

With regards to the refusal/acceptance rates of Freedom of Information (FOI) requests received within the force, there is no information held in relation to these figures being held as percentages. However, as you have requested the raw data, I have provided this information to you in the following tables below. These tables demonstrate the number of requests that have been completed over the time frames requested.

However, please note, that the disclosure of this information comes with various caveats. For example, where within the table it asks for whether a request was refused or not in the tables below, please be aware that with many of these requests, despite it being marked as "Y" (Yes) to demonstrate that the request was refused, this does not necessarily mean

that all of those marked "Y" were in fact requests that were refused in their entirety. With many of these requests, whilst some exemptions may have applied, other elements of a request may have been complied with, so a partial release of information may have still taken place.

The information supplied relies upon those inputting the data to do so correctly and ensuring that all exemptions relevant to a request are noted accurately, therefore, please keep in mind that exemptions/refusals may not have been noted where appropriate and that some of the fields may not have been reliably used.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Wiltshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing to the:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Force Disclosure Unit within 20 working days of the Force's response to the original FOI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing to include confirmation of the reasons for the review. The review will be conducted by another Decision Maker, who is independent from the original Decision Maker. The Force Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to 40 working days.

The Independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

On completion of the review the Independent Decision Maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review, they should contact the Information Commissioner to make an appeal.
