I write in connection with your request for information dated 20th March 2024 concerning Crime Reports at Gyms.

I am required by the Freedom of Information Act 2000 to handle all requests in a manner that is blind as to the identity and motives of the requestor. Any information released as a response to a request is regarded as being published and therefore in the public domain without caveat.

Your request for information has now been considered and – having consulted our Business Performance Team - I am now able to respond as follows.

You wrote:

Please can you provide me with the number of reports of:

- A) Sexual assault
- B) Harassment
- C) Stalking
- D) Exposure (Sexual Offences Act 2003 Sec 66)
- E) Voyeurism (Sexual Offences Act 2003 Sec 67)
- F) Upskirting (Sexual Offences Act 2003 Sec 67A)

from women at the below gym establishments in 2022 and 2023.

Please use these as keyword searches - I don't expect you to provide a breakdown of establishments. Please just provide a breakdown per crime type and year.

Our response:

For the reported years 2022 and 2023, as requested, we have undertaken a "wildcard" search of the occurrence address field on our crime recording system for any reports made to us for the offences you require.

I can confirm that having undertaken this search, we have not received ANY reports made for the offences you have listed at any addresses featuring the above Gym names.

Please Note – Wildcard or Free-Text Searches

Unless an applicant specifically asks for a wildcard or free-text search in their request (as you have), we would not normally advocate that this is an appropriate mechanism by which to undertake searches for information on our systems. Results from searches of this type invariably produce results that cannot be guaranteed as being accurate or reliable.

It needs to be remembered that the use of "wildcard" or free-text searches are limited for an number of reasons such as – but not limited to – the following :-

- a) The specific key words being sought need to physically appear in the field being searched (eg if the address of a Bannatyne gym was recorded but it did not include the specific word "Bannatyne" in it, then it would not be featured in any results generated)
- b) Wildcard or free-text searches are reliant on the specific keyword being spelt grammatically correctly in that field (eg if the crime recorder mis-spelt Bannatyne as "Banatine" per-se, again it would not feature in any results generated)
- c) There are other Gym chains (and independent gyms) where offences may have occurred and been reported to Wiltshire Police – these will potentially have been omitted as the search used was purely for the 11 gym names you requested.

The only other way of finding the information you require would be to review manually each and every crime record recorded under the crime categories you have requested to try and ascertain whether or not they fitted your criteria or not and – if so – record the details.

Given the number of those crime reports involved, undertaking this task manually would undoubtedly invoke a Section 12 (Time Cost) exemption in respect of this request and nothing would be able to be disclosed to you anyway.

I am satisfied that all the relevant information has been passed to me and been considered in the light of your request within the time constraints applicable under the legislation.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Wiltshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing to the:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Force Disclosure Unit within 20 working days of the Force's response to the original FoI request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing to include confirmation of the reasons for the review. The review will be conducted by another Decision Maker, who is independent from the original Decision Maker. The Force Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to 40 working days.

The Independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Decision Maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
