I write in connection with your request for information dated 09/01/2026 concerning Cyber and Security Risks.

I am required by the Freedom of Information Act 2000 to handle all requests in a manner that is blind as to the identity and motives of the requestor. Any information released as a response to a request is regarded as being published and therefore in the public domain without caveat.

Your request for information has now been considered and I am able to respond as follows.

You wrote and Our Response :

1. *The number of occasions on which cyber or information security risks appeared on the agenda of your governing body (or equivalent oversight body). **These are discussed at bi-monthly Information Security Governance Board (ISGB) meetings.***
2. *The name(s) of any committee(s) or board(s) with formal responsibility for cyber or information security oversight. **ISGB (Information Security Governance Board)***
3. *Whether documented criteria exist for escalating significant cyber incidents to the governing body or senior leadership (yes/no; if yes, please provide or summarise).*

Wiltshire Police uses nationally standardized cyber-incident severity categories and an internal risk-assessment matrix to determine when incidents are escalated to senior leadership, and when cross-organizational coordination is required.
4. *The number of governing body members (or equivalent) who completed cyber or information security training during this period, and the total number of members in that body.*

Training includes:

- ***Mandatory cybersecurity awareness***
- ***Phishing and USB-risk modules***

- *Annual or 6-monthly refreshers (per internal training provisions)*

5. Whether an independent assessment of your cyber security arrangements (e.g. internal audit, external review, or third-party assessment) was reported to the governing body during this period (yes/no; if yes, please state the type of assessment). *An annual check approved and iterative assessments through PDS engagement.*

I am satisfied that all the relevant information has been passed to me and been considered in the light of your request within the time constraints applicable under the legislation.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Wiltshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing to the:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Force Disclosure Unit within 20 working days of the Force's response to the original Fol request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing to include confirmation of the reasons for the review. The review will be conducted by another Decision Maker, who is independent from the original Decision Maker. The Force Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to 40 working days.

The Independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

Keeping Wiltshire Safe

On completion of the review the Independent Decision Maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
