Dear XXXXX,

I write in connection with your request for information dated 22nd August 2025, concerning theft of copper from car charging units.

I am required by the Freedom of Information Act 2000 to handle all requests in a manner that is blind as to the identity and motives of the requestor. Any information released as a response to a request is regarded as being published and therefore in the public domain without caveat.

Following receipt of your request, research was conducted by the Business Intelligence department at Wiltshire Police.

Your request for information has now been considered and I am able to respond as follows.

You wrote:

I would like the following, please:

- The number of thefts logged by your force which include the terms 'copper' 'electric' 'charger' 'car' in the summary of the offence for the year to date
- Please provide the figure for each of the following years: 2024, 2023, 2022, 2021, 2020

As you can tell, I am aiming to collect data on the number of thefts of copper from car charging units, both public and privately owned, to see if there has been a rise.

Our response:

Please note: This response is provided by completing a summary search for the term "copper", "electric", "charger" and "car". The accuracy and reliability of these searches cannot be guaranteed as only the MO / summary field of the report is searched. If this term is mentioned elsewhere (i.e. within the call log, crime report, statements etc) these will not be returned in the results. Additionally, if the term is misspelt within the MO / summary field, this will not be returned. To provide accurate results would require manually interrogating each crime within the specified timeframe to establish its relevance to your request.

There are **no** results returned for occurrences which include all 4 terms mentioned within this request.

- Occurrence summaries for results returned for "car" - which also included one of the other terms ("copper", "electric" or "charger") - were checked, however there was nothing relating to copper theft from EV chargers.

There were 5158 results returned for the terms specified under the crime group 'theft offences'.

I am satisfied that all the relevant information has been passed to me and been considered in the light of your request within the time constraints applicable under the legislation.

Freedom of Information Request Appeals Procedure

1. Who Can Ask for a Review

Any person who has requested information from Wiltshire Police, which has been dealt with under the Freedom of Information Act, is entitled to complain and request an internal review, if they are dissatisfied with the response they received.

2. How to Request a Review

Requests for review of a Freedom of Information request must be made in writing to the:

The reference number, date of the request and details of why the review is being requested must be included. Requests for review should be brought to the attention of the Force Disclosure Unit within 20 working days of the Force's response to the original Fol request.

3. Review Procedure

Receipt of a request for review will be acknowledged in writing to include confirmation of the reasons for the review. The review will be conducted by another Decision Maker, who is independent from the original Decision Maker. The Force Disclosure Unit will set a target date for a response. The response will be made as soon as is practicable with the intention to complete the review within twenty working days. In more complex cases the review may take up to 40 working days.

The Independent Decision Maker will conduct a review of the handling of the request for information and of decisions taken, including decisions taken about where the public interest lies in respect of exempt information where applicable. The review enables a re-evaluation of the case, taking into account the matters raised by the complaint.

4. Conclusion of the Appeal

On completion of the review the Independent Decision Maker will reply to the complainant with the result of the review. If the complainant is still dissatisfied following the review they should contact the Information Commissioner to make an appeal.
