I write in connection with your request for information dated 4th September regarding sexual offences.

I am required by the Freedom of Information Act 2000 to handle all requests in a manner that is blind as to the identity and motives of the requestor. Any information released as a response to a request is regarded as being published and therefore in the public domain without caveat.

Following receipt of your request, research was conducted by Team Performance at Wiltshire Police.

Your request for information has now been considered and I am able to respond as follows.

You wrote:

I would like to request the following information for the period of 2024, and 1 January 2025 to 2 September 2025:

1. The total number of recorded sexual offences in your police force area, for 2024 and 2025 (to September).
2. The number of recorded sexual offences where the alleged perpetrator was not a British national, for 2024 and 2025 (to September).
3. If available, a breakdown of the alleged perpetrators by nationality, for 2024 and 2025 (to September).
4. If available, a breakdown of offence types (e.g., rape, sexual assault, harassment) allegedly committed by non-British nationals for 2024 and 2025 (to September).
